Skapura said he has experience in the Teaching Academy and because of the workload; he has reduced the duration from 8 weeks to 4 weeks. Each academy must have 16 people enrolled to offer it. He suggested ranking them by how popular they think it will be.

Skapura said none of the proposals have been offered before but he does not know if they have applied previously.

Organ said he sees a theme of online pedagogy among the current proposals. Skapura said there is a drop off interest during the year so when they are offered should be spread out. He thinks offering 3-4 would probably be successful.
