SECOND ANNUAL 4CD DISTRICT PLENARY STUDY SESSION (information/discussion) Council will discuss and plan the DW Academic Senates Plenary session Equivalency Workshop on April 10, 2017. -Agenda Topics -District Marketing -Senators registration deadline Council discussed logistics for the April 10, 2017 DW Senate Plenary Session. The event will take place from 3-5pm in the DO 6th Floor Board Room. Council agreed there would not be a regular FSCC meeting in April. Goehring will work with Montemeyer-Lenz on refreshments. Council discussed possible topics for the session. They include District equivalencies for AA's and MA's; Equity, Pathways, non-credit through line and the SP (Satisfactory Progress) grade; and Meta Majors or academic clusters. Council will continue planning for the session at their February meeting.
8.	 SANCTUARY DISTRICT PETITION (information/discussion) Council will discuss the petition to establish CCCCD as a sanctuary district that is on the December Governing Board Agenda. Henderson reminded Council there is a special Governing Board Meeting tonight to vote on a resolution about declaring the district a safe place for immigrants – legal and illegal. McBrien said there is some concern about using the word sanctuary and possible legal issues so it is not used in the resolution. Henderson said LMC is not sure this is a senate item. He said the senates should be bipartisan. LMC has not put anything on their agenda yet about this issue. McBrien said Andy Barlow will be advocating to the board to pass the resolution. He asked if the FSCC would back him but she is not comfortable with FSCC representing the senates or the colleges on this. Goehring said the CCC population is at more risk than the other two colleges as they have a higher population of DACA and other immigrant students. She said they have had some events to discuss support for those groups but they were not well attended. Council agreed to keep politics off the senate table.
