Kelly Schelin has met with VPs – at each college there is some policy language on this. LMC's is most formalized/developed (March '22). Natalie H. and Kim S. worked on this. 4008.01 at LMC and DVC. Both versions talk about how programs could be placed on watch. At CCC, May 2012, Senate passed a policy statement related to this (E5005). Criteria speak to declining enrollment, productivity trends, completion/success rates. For CE courses, current language on "Declining industry demand or lack of labor market demand" is a bit too long (3 years). We need to prioritize. LMC's allows two years for a program to be on watch, if no improvements, then moves to in trouble.

Program Review triggers entire process. # of programs recently listed as "on watch" because they had not completed Program Reviews in a # of years.

Ed. Planning Processes have historically been a conversation between VPI and Academic Deans.

Next steps: ensure that everyone is looking at the same #s. VPIs and Senate Leadership should come together and discuss prior to Ed Planning Report drafts being finalized.

Kelly S. – Per President of ACCJC, we do not need to have disaggregated SLO assessment data. Colleges need to be looking at student outcomes disaggregated across demographic categories. This can be at the course/program-levels looking at student success and completion rates.

### 12. | COLLEGE/ACADEMIC SENATE UPDATES (information/discussion)

The CCC Academic Senate Council invited VP of Business and Administrative Services Victoria Menzies to present the proposed revisions to the resource allocation process. Council members provided feedback to increase transparency and clear communication to faculty throughout the process. VP Menzies will incorporate the Council's feedback and will bring the process back for a second read and approval. After hearing several concerns about the new CCC website, the Council requested feedback from all faculty. The comment period has closed. The Academic Senate President will request a meeting with marketing to discuss faculty concerns.

The Academic Senate President presented all the input on transparency, communication, and decision-making provided by All College Day participants. Council members emphasized the importance of closing the loop by following up on the input received. This input can also guide the revision of college procedures to improve campus climate.

The Council also heard a draft of the new Student Equity Plan from the Dean of Research and Planning.

DVC: At it's recent meetings, the DVC Senate Council heard reports from the Tutoring Advisory Committee and Curriculum Committee Chairs, and learned about DVC's Communities of Practice Instructional Rounds program. VPEI Joe Gorga discussed proposed changes to the structure and oversight of our Student Center Teams. Heard from DVC Code of Conduct officers on code of conduct and reporting processes, timelines, and what faculty and students can expect when a report is filed. Council approved an election process and timeline for Senate President and Vice President positions. A senate workgroup was formed to revise and update our 2018 Resolution that Reaffirmed our Commitment to Academic Freedom. VPBSS Sara Parker provided an over of current state, district and college budget projections for the next fiscal year. Council approved a CalGETC GE Certificate and reviewed draft Program Review templates and prompts for instruction and student services IUPRs.
