CCC — The Academic Senate Council requested the presence of VPBAS Vicky Menzies to go over the resource allocation process. The Council provided feedback on the process with the goal of increasing transparency and clear communication. VP Menzies is currently making revisions based on the Academic Senate Council's input and will bring the process back for approval.

We reached mutual agreement with President Rogers and VP Jason Berner to involve faculty in the planning of the agenda for All College Day. The Council is reviewing the input that we solicited from all All College Day participants last semester. The plan is to share the survey results with everyone and to respond to it. There have already been a number of resolutions and informal agreements that address the issues of lack of transparency and lack of timely and clear communication. The AS Council is planning to address the volume of email, which was one of the main concerns survey participants shared. We are planning to do a training on effective email communication during All College Day.

The Academic Senate Council continues its efforts to increase capacity for leadership and advocacy in academic and professional matters. To that end, we have sent four members to the Spring 2025 Plenary and will send 11 to the Leadership Institute in June. We will also have our 5th Faculty Collegiality Day this coming Friday, the focus of which is to develop greater communication and collaboration among faculty.

DVC – The DVC Senate recently approved a revised General Education philosophy statement, as well as updates to our Flex Week schedule—which will now include themes and designated time blocks. We also passed a resolution affirming that academic freedom is inseparable from our commitments to inclusion, diversity, equity, anti-racism, and accessibility.

Most recently, the Senate Council heard updates on AB1705 from the Math Department and reviewed a proposed AB1705 resolution from FACCC that's currently circulating. We also received a report from Vice President Sara Parker on our waste reduction efforts, reviewed a revised draft of the Help Desk Services &

Operations Agreement, discussed proposed changes and guidance related to Canvas Global Announcements, and approved draft templates and prompts for both instructional and student services Program Review.

LMC – approved CI4016, BP5028, BUS8.40, HR4000.02, and did a first read on BP 4001 and CI 4007. Finalized the language for eminence with a few minor changes (pronouns), and considering modifications for operational guidelines for meetings.

## 5. TECHNOLOGY TOOLS – CURRICULUM/CATALOG, ASSESSMENT, PROGRAM REVIEW, AND SCHEDULING (information/discussion)

The FSCC discussed recent updates from the Consultation Council, noting that the District Office appears to be encouraging a transition to CourseDog and has expressed a clear preference for consistency across colleges in the selection of software platforms. Attendees of the recent CourseDog demonstration found the tool promising but emphasized the importance of exploring other technology tools and consulting with colleges that are currently using CourseDog. LMC plans to use forms and spreadsheets for the 2025–2026 Program Review cycle. Given that all colleges will be working to implement their revised program review processes during that period, FSCC agreed that having a contingency plan will be important, as it seems unlikely that a district-wide solution will be in place by Spring 2026.
