#### **Governing Board Meeting of August 30, 2006**

The Contra Costa Community College District (CCCCD) Governing Board met in the George R. Gordon Education Center, Martinez, California on August 30, 2006. The meeting began with a closed session at 5:00 p.m. followed by open session at 7:15 p.m. Highlights of the meeting follow:

#### **New Contract Faculty Reception**

The Governing Board hosted a reception in the District Office lobby for the 34 newly hired full-time faculty at all three colleges.

#### 2006-07 Adopted Budget

Interim Vice Chancellor, Finance and Administration Doug Roberts presented the attached 2006-07 adopted budget (Board Report No. 13-B). The overall presentation included a multi-year projection of the District's Unrestricted General Fund, through 2009-10, and showed the District maintaining a minimum 5% reserve throughout, as well as initiating funding towards the General Accounting Standards Board (GASB) 45 liability in 2007-08.

## Approval of Contracts for Interim President, Diablo Valley College, Interim Vice Chancellor, Finance and Administration and Interim Vice Chancellor, Human Resources and Organizational Development

The Governing Board approved the contracts for the above members of Chancellor's Cabinet (Board Report No. 14-B).

#### Receipt and Public Hearing on District and Public Employees Union, Local 1's Initial Joint Proposal for Contract Reopeners for the Period 2006-2007

Interim Vice Chancellor, Human Resources and Organizational Development Eugene Huff reported that the District and Local 1 are in agreement on the reopeners for the new contract period. More information will follow as negotiations continue through the interest based bargaining (IBB) process.
