Governing Board Meeting of October 25, 2006

The Contra Costa Community College District (CCCCD) Governing Board met in the George R. Gordon Education Center, Martinez, California on October 25, 2006. The meeting began with a closed session at 5:30 p.m. followed by open session at 7:00 p.m. Highlights of the meeting follow:

Resolution to Negotiate a Project Labor Agreement

The Governing Board unanimously approved the attached resolution to negotiate a Project Labor Agreement (Board Report No. 32-C).

Retiree Health Benefits Funding Strategy (GASB 45 Compliance)

The Governing Board supported the Chancellor's Cabinet recommendation to move FTES from 2006-07 into 2005-06 in order to generate enough dollars to fund the District's previously negotiated retiree health benefits liability. The FTES will total more than \$15M over a two year period and fully fund the liability in 30 years, with no increase in the annual contribution currently made by the District. The proposal was shared at this meeting for three reasons: (1) it involves moving a large number of FTES from 2006-07 into 2005-06; (2) the deadline for moving the FTES is November 1; and (3) the District will be on stability this year because the enrollment goal will not be reached. This action would be a critical step in establishing fiscal stability and reliability for current and future negotiations. This action also means that the District may have more funds available in the future because the annual contribution to the fund will not be more than \$1M if current projections hold. The one-time generated funds resulting from this action will not have to be re-paid.

Resolution in Support of Proposition 1D, the Kindergarten-University Public Education Facilities Bond Act of 2006

The Governing Board approved this resolution (Board Report No. 31-A) in support of Proposition 1D which will provide \$10.4 billion for relieving overcrowding and making safety repairs and upgrades to serve the educational needs of 2.5 million students statewide currently enrolled in elementary, middle and high schools, community colleges and universities. If passed, community colleges will receive \$1.5 billion of the total.

College Personal Computer (PC) Inventory

Mojdeh Mehdizadeh, Vice Chancellor, Technology Systems Planning and Support, gave a report that showed the colleges meet the requirement of providing PCs for a minimum of 80% of management and staff. A high proportion of the computers, however, are past the recommended life cycle.

Draft Profile for President of Diablo Valley College

The process for hiring college presidents provides for input from the Governing Board. The Board provided input on the draft developed by the committee. The profile will be on the November agenda for approval by the Board. The proposed timeline indicates that a new president should be hired by July 1, 2007.

Resolution No. 32-C of the Contra Costa Community College District to Negotiate a Project Labor Agreement

Whereas, the Contra Costa Community College District ("District") is considering the development and construction of various project(s) throughout the District in connection with its Measure A 2006 Bond Funds; and

Whereas, it is essential that the construction work required in connection with the Measure A 2006 Bond be done in an efficient and economical manner so as to secure optimum productivity and to eliminate delays in the construction operations, thus ensuring timely completion in the work undertaken by the contractors; and

Whereas, the District desires to enter into a project labor agreement ("Project Labor Agreement") with appropriate building and construction trade councils and related unions to be implemented and enforced on certain projects funded exclusively by the Measure A 2006 bond; and

Whereas, it is the District's intent to negotiate and enter into a Project Labor Agreement with appropriate building and construction trades council and related unions to ensure all contractors performing work on the project(s) comply with all requirements under the California Labor Code applicable to the project(s), including, but not limited to, prevailing wages and apprenticeship; and

Whereas, it is the intent and purpose of the Project Labor Agreement to provide, establish and put into practice effective methods for the settlement of labor disputes which may arise on the project(s) covered without strike, lockout, work stoppage, or slowdown, to the end that the project(s) shall be assured of continuity of operation; and

Whereas, the District desires to authorize its Chancellor or her designee to negotiate a Project Labor Agreement with appropriate building and construction trades council and related unions to take any and all action necessary to further the District's interests in negotiating the Project Labor Agreement.

Therefore, be it resolved by the Governing Board of the Contra Costa Community College District:

- 1. The above recitals are true and correct.
- That the District's Governing Board hereby approves the negotiation of a Project Labor Agreement with appropriate building and construction trades counsel and related unions, which, upon adoption by the Governing Board, shall become part of the bid specifications that all contractors must follow on the identified project(s).
- That the District's Chancellor or her designee is authorized to negotiate the Project Labor Agreement and to take any and all action necessary to further the District's interests in the negotiation of the Project Labor Agreement.
- 4. That the final negotiated Project Labor Agreement will be presented to the Governing Board for review and approval.

5. That this Resolution shall be effective as of the date of its adoption.
