Highlights of the meeting are:

In **Board Report No. 59-A**, the Governing Board approved and welcomed the employment of Tim Leong, the new Director of Communications and Community Relations.

Financial Performance Indicators Report

Associate Vice Chancellor/Chief Financial Officer Doug Roberts reported that with 58% of the fiscal year completed, the District continues to make good fiscal decisions and has spent 57% of its budget. In addition, enrollment is up 2.5% Districtwide, with the LMC campus leading the increase.

Governing Board to Greet Foundation Members

The Governing Board's master planning calendar was finalized for 2008 which will include the opportunity to meet Foundation board members at each of the colleges. Special study sessions will also be held on the following topics: budget (April); accreditation self-study reports (July); and student learning outcomes (November).
