Governing Board Meeting of July 25, 2007

The Contra Costa Community College District (CCCCD) Governing Board met at Diablo Valley College on July 25, 2007. The regular meeting/study session began with a closed session at 4:00 p.m., followed by an open session at 5:00 p.m. Highlights of the meeting follow:

Recognition of Appreciation

The Governing Board recognized Dr. Diane Scott-Summers with a special resolution for her professionalism and for her many contributions as Interim President of Diablo Valley College from 2006 to 2007.

Information Technology in Contra Costa Community College District

Mojdeh Mehdizadeh, Associate Vice Chancellor, Chief Information Officer presented a historical report on information technology in the District from 1973 to present and Frank Vaskelis, Partner, Strata Information Group, summarized current and future technology needs.

Measure A 2006 Bond Sale and Rating

In **Board Report No. 5-A**, Associate Vice Chancellor, Chief Financial Officer Doug Roberts said the sale of Measure A bonds would take place on August 1, 2007. He further stated that the District received a rating of "AA," which is the second highest rating an institution can receive and reflects the District's very strong financial standing.

Ratification of Contract for Vice Chancellor, Districtwide Planning and Educational Services

In **Board Report No. 6-C**, the Governing Board approved the contract for Dr. Deborah G. Blue for Vice Chancellor, Districtwide Planning and Educational Services. This position will focus on coordination of educational services, research and planning, community relations, international education and technology services.

Approval of Tentative Agreement with Public Employees Union, Local 1

Outgoing Local 1 President Bernadette Green announced that members voted 220 to 31 to ratify their agreement (**Board Report No. 6-D**).
