The Contra Costa Community College District (CCCCD) Governing Board met in the George R. Gordon Education Center on June 25, 2008. The regular meeting began with a closed session at 5:00 p.m., followed by open session at 6:00 p.m.

Highlights of the meeting are:

### Welcome New Student Trustee

#### **New Agreements Approved**
