Governing Board Regular Meeting/Study Session of April 29, 2009

The Contra Costa Community College District (CCCCD) Governing Board met at the Brentwood Center, Room 3, on April 29, 2009. The regular meeting/study session began with a closed session at 4:00 p.m., followed by open session at 5:00 p.m.

Highlights of the meeting are:

2009-10 District Budget Planning Study Session

The Governing Board reviewed the District's planning process for the 2009-2010 budget, and included a presentation by Rael & Letson's Jean Vergara on the actuarial valuation of the District's post-retirement benefits.

2007-08 Measure A Bond Fund Audit

The Governing Board reviewed and accepted the 2007-08 Measure A Bond Fund Audit Reports that were presented at the Measure A Bond Oversight Committee meeting on April 22, 2009.

New Agreements Approved

The Governing Board approved a number of agreements including the following:

- A Contra Costa College renewal agreement with the city of Richmond to offer a physical education course at the Booker T. Anderson Community Center in Richmond.
- An amended Diablo Valley College agreement with the State of California Department of Rehabilitation to provide support services to students in the Department of Rehabilitation Workability III Program.
- A District Office renewal agreement to provide District students an education abroad program in London, England.
- A new Los Medanos College agreement with the University of Southern California, Center for Urban Education, to assist in implementing the equity scorecard and benchmarking process.

Campus Alert System

The Governing Board received a brief presentation on the District's new Campus Alert System, a series of sirens located at Contra Costa College, Diablo Valley College, Los Medanos College, and the San Ramon Campus. Designed to alert and disseminate information in case of an emergency or crisis situation, the sirens will be tested on a monthly basis on the same schedule as other county sirens starting on May 6 at 11:00 a.m.
