## **Governing Board Regular Meeting of July 30, 2008**

The Contra Costa Community College District (CCCCD) Governing Board met in the Trophy Room on the Diablo Valley College campus on July 30, 2008. The regular meeting/study session began at 4:00 p.m., followed by a DVC Foundation Board reception at 6:00 p.m. The regular meeting/study session reconvened at 7:00 p.m. and continued with a closed session that began at approximately 9:00 p.m.

Highlights of the meeting are:

#### **Self Study Reports**

The Governing Board reviewed the accreditation/self study reports prepared by Contra Costa College (CCC), Diablo Valley College (DVC), and Los Medanos College (LMC).

## **New Agreements Approved**

The Governing Board approved a number of agreements including the following:

- A DVC renewal agreement with the Family Stress Center to provide Foster Pride training including facility use for Foster Care classes.
- A CCC renewal agreement with the California Department of Education for state preschool services.
- A new District agreement with Datatel to provide consultant services for the implementation of the ActiveCampus Portal.
- A LMC renewal Master Training Agreement with the Concord Police Department to provide Administration of Justice courses.

# Approved Emergency Resolution for Police Services Building at DVC

The Governing Board approved the emergency resolution declaring an emergency situation existed due to a fire at the Police Services building located at DVC, expediting the restoration of services and the replacement of facilities.

## **Approved Resolution for a New Fund in the County Treasury**

The Governing Board approved the resolution ordering the Contra Costa County Auditor-Controller and Treasurer to establish a new Self Insurance Fund in the County Treasury.

# Approved Resolution for a New Trust to Pay Obligations to Eligible Employees and Their Eligible Dependents and Beneficiaries for Health Insurance and Other Similar Benefits

The Governing Board approved a resolution that:

- Establishes a trust to be used for the purposes of investment and disbursement of funds designated by the District to pay for health insurance and other similar benefits to eligible employees, dependents and beneficiaries, and;
- The establishment of a Retirement Board Authority to provide direction and decisions for this new trust.
