Governing Board Regular Meeting of October 22, 2008

The Contra Costa Community College District (CCCCD) Governing Board met in the George R. Gordon Education Center on October 22, 2008. The regular meeting began with a closed session at 5:00 p.m. followed by open session at 6:00 p.m.

Highlights of the meeting are:

New Agreements Approved

The Governing Board approved a number of agreements including the following:

- A CCC renewal agreement with the University of California, San Francisco to provide clinical experience for students in the dental assisting program.
- A new DVC agreement with the Community Clinic Consortium to provide Federal Work Study employment.
- A new LMC agreement with the City of Pittsburg Redevelopment Agency to develop a housing development feasibility report and presentation.
- A District renewal agreement with the Chinese-American Education and Culture Exchange Center to provide international education marketing and recruitment services.

Out-of-State Field Trip Approved

The Governing Board approved travel to Kansas City, Missouri, for nine CCC students to attend the Associated Collegiate Press/College Media Advisers National College Media Convention, from October 29, 2008, to November 2, 2008.

Approval of Tentative Agreement with Local 1

The Governing Board approved the Tentative Agreement, dated September 17, 2008, with Public Employees Union, Local 1.

Approval of Tentative Agreement with United Faculty

The Governing Board approved the Tentative Agreement, dated August 27, 2008, with United Faculty.

DVC Enrollment Management Plan Discussed

The Governing Board reviewed DVC's Enrollment Management Plan for the Fall 2008 through Spring 2009.

The Governing Board meeting was adjourned in memory of Mark Eastman, a psychology instructor who worked at DVC from 1970-2004.
