# **Governing Board Meeting of April 27, 2011**

The Contra Costa Community College District (CCCCD) Governing Board met at the Los Medanos College Library Community Room on April 27, 2011. The public session began at 4:00 p.m., followed by closed session at 7:00 p.m.

Highlights of the meeting follow.

# **Governing Board Special Presentation by LMC Students**

Four students from the Los Medanos College MESA program presented their experiment to the Governing Board that was selected by NASA for testing in their very own Vomit Comet. The Vomit Comet is used for zero gravity-like experiences over the Gulf of Mexico and lets users experience the space-like feeling of weightlessness.

### **Study Session on the District Budget**

District staff led the Governing Board through a study session on the status of the FY 2010-11 District budget including the challenges faced by the District in forming planning assumptions.

# **New Agreements Approved**

The Governing Board approved a number of agreements including the following:

- A new Contra Costa College (CCC) agreement with Contra Costa County, Employment and Human Services to provide early childhood classes for the Contra Costa County Community Services Bureau staff;
- a Diablo Valley College (DVC) renewal agreement with the Chancellor's Office, California Community Colleges to administer the Statewide Puente Project;
- a new District agreement with the Chancellor's Office, California Community Colleges to serve as the lead agency and fiscal agent for the East Bay Career Advancement Academy grant, and
- a new Los Medanos College (LMC) agreement with Dowden Associates, Inc., to provide services for the development, submission and implementation of a successful Hispanic Service Institution science, technology, engineering and math grant application.

#### **Approval Given to Out-of-State Field Trips**
