Governing Board Special Meeting of March 9, 2011

The Contra Costa Community College District (CCCCD) Governing Board met at the George R. Gordon Education Center on March 9, 2011. The public session began at 3:00 p.m., with closed session at 5:00 p.m., followed by open public session at 5:30 p.m.

Highlights of the meeting follow.

Governing Board Interviews and Selects Provisional Appointment for Ward V

Following the passing of Governing Board Vice President Jess H. Reyes on January 31, 2011, the Governing Board agreed to fill the seat with a provisional appointment rather than a more costly election. An ad hoc application screening committee of two Governing Board members, Sheila Grilli and Tomi Van de Brooke, reviewed the applicants and decided to forward three applicants to be interviewed by the full Governing Board.

Following the interviews at this meeting, the Governing Board selected Robert Calone of Pittsburg as the provisional appointment to represent Ward V. Unless a petition calling for a special election, containing a sufficient number of signatures, is filed in the office of county superintendent of schools within 30 days of the date of the provisional appointment, the provisional appointment shall become an effective appointment until the next regularly scheduled election for Governing Board members in 2012.

Reduction of Academic Management Staff Approved

The Governing Board approved a resolution that approved the elimination of 5 academic manager positions effective June 30, 2011; one at CCC and four at DVC. In addition, the resolution gave approval to provide notice to all other academic management employees notice on or before March 15, 2011, that they may be reemployed for the 2011-12 academic year at a reduced number of days of service with a corresponding reduction in compensation. Affected employees may be eligible to retreat into first year probationary faculty positions. This action provides the District maximum flexibility as it faces significant financial uncertainty in 2011-12.
