## Governing Board Study Session/Meeting of April 24, 2013

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on April 24, 2013. The public meeting began with a Level VI grievance appeal hearing, followed by the study session/meeting at 4:00 p.m., and closed session at 7:30 p.m.

Highlights of the meeting follow.

### Level VI Grievance Appeal Hearing-Eric Brian Smith

The Governing Board conducted a Level VI Grievance Appeal Hearing for classified employee Eric Brian Smith, a Local 1 member. The employee submitted a grievance of alleged violations of the existing contract that were denied, and exercised his right to appeal to the Governing Board.

### Study Session

The Governing Board held a study session on the 2013-14 District budget, facilities funding options for a new Brentwood Center, and consideration of a new Districtwide bond measure to be placed on the ballot in 2014.

### New Agreements Approved

The Governing Board approved a number of agreements including:

- a new Contra Costa College (CCC) agreement with the Contra Costa County Office of Education to participate in the Medi-Cal Administrative Activities program, which draws down federal funds for work performed connecting students with Medi-Cal insurance and sponsored health services;
- a Diablo Valley College (DVC) renewal agreement with the International Education Center to provide four credit classes in the Summer 2013 semester;
- a District renewal agreement with Managed Health Network to provide a student assistance program; and
- a Los Medanos College (LMC) renewal agreement with Pittsburg Unified School District (PUSD) to provide a faculty member to participate in planning and curriculum development, team meetings and lead professional development activities with PUSD teachers.

## **Out-of-State Field Trip**

The Governing Board approved an out-of-state field trip for 16 DVC students to travel to Annapolis, Maryland, and Lewisburg, Pennsylvania, to attend two water polo tournaments from September 5, 2013, to September 13, 2013. No District funds will be used for these field trips.

## **Student Trustee Privileges**

Approval was given by the Governing Board to continue existing student trustee privileges to May 9, 2014, in accordance with Education Code 72023.5.
