Governing Board Meeting of February 27, 2013

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on February 27, 2013. The meeting began at 5:00 p.m. with closed session, followed by the public session at 6:00 p.m.

Highlights of the meeting follow.

Resolution Ratifying Emergency Action and Expenditures

The Governing Board approved a resolution ratifying two emergency actions requiring immediate facility repair and the purchase of replacement equipment. Both incidents occurred at DVC and the emergency actions helped to minimize further damage and student impact.

New Agreements Approved

The Governing Board approved a number of agreements including:

- a new Contra Costa College (CCC) agreement with The City of Richmond, to rent facilities for two, nine-week cohort training sessions in warehousing and logistics as part of the U.S. Department of Labor's Trade Adjustment Assistance Community College Career Training Initiative;
- a new Diablo Valley College (DVC) agreement with Solano Community College to provide technical assistance in the development of the Industrial Machine Maintenance Mechanic Program;
- a new District agreement with VLS Consulting to provide facilitation services for the Governing Board's Interest Based Bargaining training, and serve as a neutral third party for United Faculty and Local 1 contract negotiations; and
- a Los Medanos College (LMC) renewal agreement with Pittsburg Unified School District for seventh and eighth grade students and their parents to attend a career exploration event and learn about the associated educational requirements.

Classified Employee of the Year Nomination

The recommendation to select LMC's Carol Love as the District's classified employee of the year was approved by the Governing Board. The nominee will be considered for the Board of Governors' statewide annual Classified Employees Award.
