## Governing Board Meeting of March 27, 2013

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on March 27, 2013. The meeting began with a reception for newly tenured faculty at 5:00 p.m., followed by the public meeting at 6:00 p.m.

Highlights of the meeting follow.

### Reception for Newly Tenured Faculty

The Governing Board attended a reception for newly tenured faculty in the District Office lobby. Also recognized at this reception was Carol Love, a Los Medanos College employee and the District's Classified Employee of the Year. Carol will now be considered for the Board of Governors' statewide annual Classified Employees Award.

### Conversation on Ethnic Diversity in the District

A strategic conversation on the District's ethnic diversity was held by the Governing Board and facilitated by DVC's Peter Garcia. Community leaders, students and staff participated in the conversation and discussed next steps in addressing this issue.

### New Agreements Approved

The Governing Board approved a number of agreements including:

- a Contra Costa College (CCC) renewal agreement with the Hilltop Community Church for facility use for the Nursing Program pinning ceremony;
- a Diablo Valley College (DVC) renewal agreement with the State of California, Department of Rehabilitation to provide support services to students in the Department of Rehabilitation Workability III Program;
- a new District agreement with Jessica Pitt to provide consulting services for the implementation of key regional components of the Trade Adjustment Assistance Community College Career Training Grant; and
- a Los Medanos College (LMC) renewal agreement with Parent Institute for Quality Education to provide a nine-week parent training course.
