Governing Board Meeting of May 28, 2014

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on May 28, 2014. The meeting began with closed session at 5:00 p.m., followed by the public meeting at 6:00 p.m.

Highlights of the meeting follow.

Student Trustee Receives Governing Board Recognition

Outgoing Student Trustee Ivan De Los Santos was recognized by the Governing Board for his contribution to the District during the 2013-14 academic year.

Governing Board Applauds Diablo Valley College (DVC) Swim Teams

The Governing Board publicly recognized the DVC women's swim team for winning the state title, and DVC men's swim team for placing 5th in the state. Both teams claimed increased motivation to excel following the death of former DVC student and swimmer Lauren McCullough.

New Agreements Approved

The Governing Board approved a number of agreements including:

- a new Contra Costa College (CCC) agreement with the Wright Institute to develop and provide clinical services and training for Middle College High School students;
- a new DVC agreement with Keenan & Associates to review and develop a safety program aligned with Cal-OSHA standards for the Engineering Technology and Construction programs;
- a new District Office (DO) agreement with the Workforce Development Board of Contra Costa County to provide support services to the Trade Adjustment Assistance Community College Career Training DBS cohorts; and
- a Los Medanos College (LMC) renewal agreement with Contra Costa County, Fire Protection District to provide ride-along, patient contacts and clinical experiences for EMT students.

Resolution for November 4, 2014, Governing Board Election

The Governing Board approved a resolution ordering the Superintendent of Schools of Contra Costa County to call for an election on Tuesday, November 4, 2014, for the purposes of electing Governing Board members in Wards I, III, and IV.
