The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on October 2, 2013. The meeting began at 5:30 p.m.

Highlights of the meeting follow.

Discussion to Determine Interviewees for Ward III Governing Board Vacancy

The Governing Board discussed the interview process and decided to revise the selection process that was approved at their September 11, 2013, meeting. Due to a deviation of the process by a board member, the Governing Board decided to interview all 12 candidates at their October 8, 2013, instead of identifying a smaller number of candidates to interview. Unless a petition calling for a special election, containing a sufficient number of signatures, is filed in the Office of County Superintendent of Schools within 30 days of the date of the provisional appointment, the provisional appointment shall become an effective appointment until the next regularly scheduled election for Governing Board members in November 2014.
