# Governing Board Study Session / Meeting of April 22, 2015

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on April 22, 2015. The study session/regular meeting began with closed session at 3:00 p.m., followed by open session at 4:00 p.m. Highlights of the meeting follow.

## **Budget Study Session**

The Governing Board conducted a study session on the development of the District's 2015-16 budget.

### **New Agreements Approved**

The Governing Board approved a number of agreements including:

- a Contra Costa College (CCC) renewal agreement with Fondazione Marco Polo to provide services for six students to study Culinary Arts in Parma, Italy;
- a new Diablo Valley College (DVC) agreement with Modern Disability to provide speaker services and a professional development workshop;
- a new District Office agreement with Cabrillo Community College District to develop, enhance, retool and expand quality career technical education offerings as the fiscal agent for the Career Technical Education Enhancement Fund grant; and
- a Los Medanos College (LMC) renewal agreement with Sutter Delta Medical Center to provide clinical experience to students enrolled in the Emergency Medical Technician program.

# **Out-of-State Field Trips**

The Governing Board approved the following three out-of-state field trips.

- Six CCC students will to travel to Rome and the Amalfi Coast, Italy, to attend culinary school from May 30-June 17, 2015. All costs will be paid for through fundraising activities, and no college funds will be used.
- 43 LMC students will travel to Reno, Nevada, to tour the University of Nevada, Reno (UNR) on May 1, 2015.. All costs will be paid by UNR and no college funds will be used.

 Five LMC students will travel to Portland, Oregon, to present research at the Community College Undergraduate Research Initiative (CCURI) Spring Regional Conference and Student Poster Session from May 19-22, 2015. All costs will be paid by CCURI and LMC.

#### **Student Trustee Privileges Extended**

Governing Board approval was given to extend the existing student trustee privileges to May 6, 2016, in accordance with Education Code 720223.5: Those privileges include:

- expressing the student position with an advisory vote on matters that do not pertain to collective bargaining, confidential personnel and legal matters discussed in closed session; and
- receiving compensation of \$400 per month.

#### **Citizens Bond Oversight Committee Member Approved**

The Governing Board approved the appointment of Keith Montes to the Measures A 2002/2006 and Measure E 2014 Citizens Bond Oversight Committee. He will be filling the seat as the DVC student representative with a two-year term that ends on June 30, 2017.
