## Governing Board Meeting of June 28, 2017

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on June 28, 2017. The meeting began with closed session at 4:00 p.m., followed by public session at 6:00 p.m.

Highlights of the meeting follow.

### New Student Trustee

Governing Board President Vicki Gordon administered the oath of office to new Student Trustee and Diablo Valley College (DVC) student, Jessica Cisneros.

### New Agreements Approved

The Governing Board unanimously approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with the University of California, Davis, to provide support services to increase the number of transfer ready students;
- a DVC renewal agreement with First 5 Contra Costa Children and Families Commission to provide instructional and administrative support services;
- a District Office renewal agreement with the American Red Cross to use District facilities in the event of a crisis or emergency situation; and
- a Los Medanos College renewal agreement with Contra Costa Fire Protection District to provide facilities and equipment for the Technology/Fire Academy Program.

### Out of State Field Trip

The Governing Board gave approved to the following out-of-state field trip.

- Eighty DVC students will travel to Las Vegas, Nevada, to visit and tour the University of Nevada, Las Vegas and Nevada State College from July 26, 2017, to July 28, 2017. Categorical funding will cover costs for this trip.

### **Approval of 2017-18 Tentative Budget**

The Governing Board reviewed and unanimously approved the District's 2017-18 Tentative Budget.

### **New Citizens Bond Oversight Committee Member**

Approval was given by the Governing Board to appoint Luanna Waters as the CCC student representative to the District's Citizens Bond Oversight Committee. This is the third term for Ms. Waters that will end on June 30, 2019.

The meeting was adjourned in memory of Bernice Hunn, retired CCC nursing director and Leighman Brightman, retired CCC history/sociology professor.
