Governing Board Meeting of September 14, 2016

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on September 14, 2016. The meeting began with closed session at 5:00 p.m., followed by public session at 6:00 p.m.

Highlights of the meeting follow.

Campaign for College Opportunity

Jake Brymner, Regional Affairs Manager for Campaign for College Opportunity, presented a certificate of recognition to Diablo Valley College (DVC) for its exceptional work in implementing the Associate Degree for Transfer and for being among the top ten community colleges in California to award such a degree.

2016-17 Adoption Budget

The Governing Board held a public hearing and approved the adoption budget for fiscal year 2016-17.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Contra Costa College (CCC) agreement with Rancho Santiago Community College District to provide technical assistance through the Career Technical Education Data Unlocked Initiative which provides support for CTE program development and improvement efforts;
- a DVC renewal agreement with University of California, Davis, to provide support services to increase the number of transfer-ready students;

- a District Office (DO) renewal agreement with American Institute for Foreign Study to provide study abroad programs for students studying in Florence, Italy; and
- a new Los Medanos College (LMC) agreement with Pittsburg High School to establish a high school-college counseling program.

Out-of-State Field Trip

The Governing Board approved an out-of-state field trip for four LMC students to tour Historically Black Colleges and Universities from October 25-30, 2016.

Bond Oversight Committee Members Approved

Brian Sharpes was appointed by the Governing Board to the Measure A 2006 and Measure E 2014 Bond Oversight Committee, representing DVC's college support organization. His term of office runs from July 1, 2016, to June 30, 2018.

Constitution Day

The Governing Board approved a resolution honoring September 17, 2016, as Constitution Day.

National Hispanic Heritage Month

A resolution recognizing September 15, 2016, through October 15, 2016, as National Hispanic Heritage Month, was approved by the Governing Board.
