

# Governing Board Meeting of December 14, 2017

## **Organizational Meeting**

#### **DVC Educational Master Plan 2018-2023**

Diablo Valley College (DVC) Interim Dean of Research and Planning Laurie Lema provided the Governing Board with an overview of the college's Educational Master Plan 2018-23.

### **College Integrated Plans**

The Governing Board heard a presentation and approved the colleges' 2017-19 integrated planning efforts including Basic Skills Initiatives, Student Equity, and Student Success and Support Programs.

#### **New Agreements Approved**

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with Chabot-Las Positas Community College District to participate in the California Early Childhood Mentor Program;
- a DVC renewal agreement with La Clinica de La Raza to provide a supervised oral health care experience for dental students;
- a District Office renewal agreement with Foothill-De Anza Community College District to develop a marketing and branding campaign to market career pathways more effectively and highlight community colleges and Career Technical Education programs as part of the SB 1070 grant project; and
- a new Los Medanos College (LMC) agreement with Nebraska Book Company to participate in a textbook rental program.

### **Out-of-State Field Trips**

The Governing Board approved eight out-of-state field trips for all three colleges. Details regarding these trips follow.

- Eight CCC students will travel to Daytona Beach, Florida, to attend and compete in the Phi Rho Pi National Speech and Debate Tournament from April 9-14, 2018.
- Eight CCC students will travel to Chicago, Illinois, to attend the 2018 Alliance of Hispanic Serving Institution Educators National Conference from March 24-28, 2018.
- One CCC student will travel to San Antonio, Texas, to attend the Student Veterans of America National Conference from January 3-7, 2018.
- Six DVC students will travel to the University of DeKalb, Illinois, to participate in the Mid-America Forensics League Tournament from January 27-28, 2018.
- 16 DVC students will travel to Spelman College, Atlanta, Georgia, to attend the United Collegiate Women's Conference from April 12-15, 2018.
- Five LMC students will travel to colleges and universities in Georgia, Florida, and Louisiana to participate in the Historically Black Colleges and Universitie4s Tour from March 25-30, 2018.
- 24 LMC students will travel to Spokane, Washington, to attend and participate in the Region 7 Kennedy Center American College Theater Festival from February 18-24, 2018.
- 43 LMC students will travel to the University of Nevada, Reno, to participate in a tour of the college on March 2, 2018.
