Governing Board Meeting of February 28, 2018

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on February 28, 2018. The public meeting began with closed session at 5:00 p.m., followed by the public meeting at 6:00 p.m.

Highlights of the meeting follow.

Classified Employee of the Year

The Governing Board approved the recommendation by the District's Classified Senate to recognize Los Medanos College's Beth Ann Robertson as the District's Classified Employee of the Year. Her nomination will be forwarded to the Board of Governors' for their annual Classified Employees Award.

Out-of-State Field Trips

The Governing Board approved the following Diablo Valley College (DVC) out-of-state field trips.

- Seven students will travel to Daytona Beach, Florida to participate in the Phi Rho Pi National Tournament from April 9, 2018, to April 14, 2018.
- Five students will travel to Colorado Springs, Colorado to participate in the American Forensics Association National Tournament from April 6, 2018, to April 9, 2018.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with Gateway to College National Network to provide funding to support operating expenses of the Gateway to College program;
- a DVC renewal agreement with Contra Costa County Library to provide library services via the Dougherty Station Library for the San Ramon Campus;
- a District Office renewal agreement with Contra Costa County, Office of the Sheriff, to cover mutual aid services in the event that disaster or emergency coverage is required; and
- a Los Medanos College (LMC) renewal agreement with Mesa West Outdoor to provide digital billboard advertising services.

Citizens' Bond Oversight Committee

Keith Archuleta of Emerald HPC International, was approved by the Governing Board to serve as the LMC Business representative on the Citizens' Bond Oversight Committee.

Contracts for Contract Administrators Approved

The Governing Board approved contracts for Mojdeh Mehdizadeh to return to her previously held position of Executive Vice Chancellor, Education and Technology, and Dr. Chui Tsang as the Interim CCC President.
