Governing Board Meeting of March 28, 2018

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on March 28, 2018. The public meeting began with closed session at 5:00 p.m., followed by the public meeting at 6:00 p.m.

Highlights of the meeting follow.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Contra Costa College (CCC) agreement with Vivianne Hiriart Riedemann Qualitative Research to conduct a market research project to facilitate improved understanding of the needs, motivations, fears and barriers adult learners have in regard to higher education;
- a Diablo Valley College (DVC) renewal agreement with Campus Labs, Inc., to provide a web-based student organization management tool to increase communications and improve training of student leaders and advisors;
- a new Districtwide agreement with University of California, Davis Extension to establish a higher education institutional partnership to benefit the parties in the recruitment and retention of international students; and
- a Los Medanos College (LMC) renewal agreement with Tuolumne Trails for the use of the Camp Tuolumne Trails for the Honors Transfers Program retreat.

Out-of-State Field Trips

The Governing Board approved the CCC out-of-state field trips listed below.

- Ten students will travel to Rome, Amalfi Coast and Otronto, Italy, for Italian culinary arts study from May 26, 2018, to June 11, 2018.
- Three students will travel to Minneapolis, Minnesota, to attend the annual National Association of Chicana and Chicano Studies Conference from April 5, 2018, to April 7, 2018.

Adult Education Consortium

The Governing Board approved CCC's Kelly Schelin to replace Executive Vice Chancellor, Education and Technology Mojdeh Mehdizadeh as the college's representative on the Steering Committee for the Adult Education Consortium.
