Governing Board Meeting of August 22, 2018

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on August 22, 2018. The meeting began at 5:00 p.m. with closed session, followed by the public meeting at 6:00 p.m.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with The San Pablo Economic Development Corporation to provide educational and childcare cost assistance to students enrolled in select career technical education programs;
- a new Diablo Valley College agreement with Contra Costa County, Employment and Human Services to provide funding for tuition and textbooks for a targeted group of county head start employees participating in the DVC Early Childhood Education linked ESL/ECE Associate Teacher Certificate Program;
- a District renewal agreement with Simpson Investigative Services Group to provide consulting services and pre-employment background investigations for District police services; and
- a new Los Medanos College (LMC) agreement with Santa Clarita Community College District to receive funding to strengthen integrated planning, resource allocation and institutional effectiveness, and expand the distance education offering and programs as part of the innovation and effectiveness grant.

Out-of-State Field Trips

The following out-of-state field trips were approved by the Governing Board.

- Six CCC students will attend the 2018 Society of Hispanic Engineers National Conference from November 6-11, 2018, in Cleveland, Ohio.
- Five LMC students will attend the Community College Undergraduate Research Initiative Fall 2018 Colloquium from November 28-30, 2018, in Glendale, Arizona.

College and Career Access Pathway Agreement

The Governing Board approved a College and Career Access Pathways agreement between CCC and Griffin Technology/Mare Island Technology Academies.

The meeting was adjourned in the memory of Frances Brown, retired DVC art professor, and Robin (Brooke) Eubanks, CCC English professor.
