Governing Board Regular Meeting June 26, 2019

The Contra Costa Community College District (District) Governing Board met at the George R. Gordon Education Center on June 26, 2019. The regular meeting began at 4:00 p.m. with closed session, followed by the public session at 6:00 p.m.

New Student Trustee Takes Oath of Office

Contra Costa College (CCC) student Shreejal Luitel was installed as the new Student Trustee for 2019-20. His oath of office was administered by Governing Board President Vicki Gordon.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a CCC renewal agreement with City of Richmond, Workforce Development Board, to partner in the resource sharing related to the Workforce Innovation and Opportunity Act by providing, non-cash, in-kind services toward the success of the project;
- a Diablo Valley College (DVC) renewal agreement with Symplicity Corporation to provide Student Code of Conduct software, training and support;
- a District renewal agreement with Contra Costa Economic Partnership to provide support services to accomplish strong workforce program goals for work-based learning employment outcomes; and
- a Los Medanos College (LMC) renewal agreement of the master instructional services agreement with Contra Costa County Office of the Sheriff to provide law enforcement courses.

2019-20 Tentative Budget

The Governing Board approved the 2019-20 Tentative Budget that includes funding sources from state general fund unrestricted and restricted federal sources, and local revenue, such as property taxes and student fees.

District Strategic Plan 2020-25

Approval by the Governing Board was given to the Contra Costa Community College District Strategic Plan 2020-25.
