Governing Board Regular Meeting/Study Session of April 22, 2020

The Contra Costa Community College District (District) Governing Board conducted a remote study session/regular meeting with closed session at 3:00 p.m., followed by public session at 4:00 p.m.

Districtwide Response to COVID-19

The Governing Board heard a presentation on how the District and its functional departments have been responding to the COVID-19 pandemic.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Diablo Valley College (DVC) agreement with Study Smart Tutors, Inc., to provide live online SAT review sessions for TRIO students enrolled in Educational Talent Search and Upward Bound;
- a new District agreement with Rancho Santiago Community College District to host the K14 Technical Assistance Provider grant for the Bay Area region to support the work of the Strong Workforce Program initiative; and
- a new Los Medanos College (LMC) agreement with FCA US LLC, to join the Mopar Career Automotive Program which includes curriculum, cars, materials and other tools.
