## Governing Board Regular Meeting of June 24, 2020

The Contra Costa Community College District (District) Governing Board conducted a remote regular meeting with closed session at 5:00 p.m., followed by public session at 6:00 p.m.

### Oath of Office for New Student Trustee Mansu Kim

Interim Chancellor Eugene Huff administered the oath of office for new Student Trustee Mansu Kim.

### New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with First 5 Contra Costa Children and Families Commission to provide funding for instructional and administrative support services for Early Childhood Education students;
- a new Diablo Valley College (DVC) agreement with Bay Area LEEDS to coordinate employer engagement strategies, activities and linkages related to the new STEM Academy partnership;
- several new and renewal agreements with various vendors to establish and maintain partnerships with international student recruiters; and
- a Los Medanos College (LMC) renewal agreement with Contra Costa County, Office of the Sherriff of the master instructional services agreement to provide law enforcement courses.

### District Diversity Report

The Governing Board heard a staff presentation on the annual workforce diversity report.

### Resolutions Approved

Among resolutions approved were one in honor of LGBTQIA+ Pride, June 2020 and another to Endorse Community and Public Safety Engagement in Social Justice Reform.

### **Institutional Self-Evaluation Reports**

The Governing Board gave final approval to the Accreditation Institutional Self-Evaluation Reports (ISER) prepared by CCC, DVC, and LMC. The three colleges prepared these ISERs for the accreditation visits that will be conducted remotely from October 5-8, 2020.

### **College and Career Access Pathways (CCAP) Partnership Agreements**

The Governing Board approved the renewal of 26 existing Contra Costa Community College District CCAP Partnership Agreements, and one new CCAP agreement with Aspire Richmond CA College Prep Academy.
