The Contra Costa Community College District (4CD) Governing Board conducted a remote regular meeting/study session on Wednesday, April 28, 2021, beginning at 3:00 p.m., followed by closed session, and continuation of public session at 4:00 p.m.

2021-22 Budget Study Session

The Governing Board conducted a study session on the development of the 2021-22 budget and the 4CD bond measure spending.

Resolution Approved

The Governing Board approved the resolution, with minor modifications, to celebrate National Community College Month during the month of April.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Contra Costa College agreement with Foundation for California Community Colleges to offer student stipends to promote CalEITC and YCTC via tabling events and social media;
- a new Districtwide agreement with VisionPoint Marketing, LLC, to provide consultant services to devise, implement and measure a robust and comprehensive enrollment marketing and management program to drive significant, attributable enrollment growth across 4CD's colleges and centers;
- a Diablo Valley College renewal agreement with Food Bank of Contra Costa and Solano to provide non-perishable and perishable food to college pantries that service students in need and their families; and
- a new Los Medanos College (LMC) agreement with Jewish Vocational Services to provide instruction and support related to fall 2020 civil service pre-apprenticeship.
