## Governing Board Meeting of March 24, 2021

The Contra Costa Community College District (4CD) Governing Board conducted a remote public meeting on Wednesday, March 24, 2021, beginning at 4:00 p.m. with the **2020 and 2021 Classified Professional of the Year and Tenured Faculty Reception**.

Sandra Mills (2020 recipient) from Los Medanos College (LMC) and Demetria Lawrence, (2021 recipient) from Contra Costa College (CCC) were honored as well as the 2020 and 2021 newly tenured faculty at the colleges: 17 from CCC, 41 from Diablo Valley College (DVC), and 21 from LMC.

This event was followed by closed session, and continuation of public session at 6:15 p.m.

### Resolutions Approved

The Governing Board approved the resolutions listed below.

- National Women's History Month, with comments by LMC's Chialin Hsieh;
- American Red Cross Month, with comments by American Red Cross' Stan Massie; and
- Denouncing Xenophobia and Discrimination against Asian Pacific Islanders Due to Fears of the COVID-19 Pandemic and Reaffirming the Contra Costa Community College District's Commitment to the Well-Being and Safety of Asian Pacific Islander Communities, with comments by Chinese American Political Association's Cheng Liao.

### New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new CCC agreement with Santa Clarita Community College District to help improve streamlining of participatory government structures and improving communication, full integration of planning and resource allocation processes, and better integration of learning outcome assessments into integrated planning;
- a new DVC agreement with Virus Geeks to administer and process weekly COVID-19 testing for the athletics department; and
- a 4CD renewal agreement with the California Community Colleges, Chancellor's Office to administer the statewide Puente Project.

### Governing Board and Chancellor 2020-21 Goals

After discussion and comments, the Governing Board approved its 2020-21 goals and those of the Chancellor.

### **DEEOAC Appointments**

Approval was given by the Governing Board to appoint community members Genoveva Calloway and Estela DePaz to the 4CD Districtwide Equal Employment Opportunity Advisory Committee. Their terms will end on June 30, 2023.
