Governing Board Regular Meeting of May 26, 2021

The Contra Costa Community College District (4CD) Governing Board conducted a remote regular meeting on Wednesday, May 26, 2021, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Outgoing Student Trustee Mansu Kim

The Governing Board heard the final report from outgoing Student Trustee Mansu Kim on his past year's work, and introduced the incoming Student Trustee Austin Green. Student Trustee Kim also received a Certificate of Appreciation from the Governing Board for his service.

Resolutions Approved

The Governing Board approved the resolutions listed below.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with West Contra Costa Unified School District to provide instructional services to the alternative education high school, Gateway to College;
- a Diablo Valley College (DVC) renewal agreement with Richmond Community Foundation to provide SparkPoint services, including financial services that support student persistence, such as budgeting, credit and financial coaching;
- a 4CD renewal agreement with McKnight Associates, Inc. to conduct reclassification studies, employee orientation/training on reclassification applications/processes and desk audits; and
- a Los Medanos College (LMC) renewal agreement with Symplicity Corporation to provide student code of conduct software, training and support.
