Governing Board Regular Meeting of August 11, 2021

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, August 11, 2021, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Distance Education Presentation

The Governing Board continued its focus on Strategic Direction 1: Improve Student Learning and Completion across the District Colleges with a presentation on 4CD progress to provide high-quality distance education.

Accreditation Final Draft Report

The Governing Board reviewed and provided feedback on the revised draft of the Accreditation Commission for Community and Junior Colleges, Western Association of Schools and Colleges Follow-up Report. The final report will be reviewed and approved at the September 8, 2021, Governing Board meeting and sent to the Commission before the October 1, 2021, deadline.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Contra Costa College agreement with EMS Software, LLC, to provide leadership team development through a series of structured workshops;
- a new Diablo Valley College (DVC) agreement with The Urban Institute to develop and implement an equity action plan to address achievement gaps for students of color in an online ARTDM program
- a District renewal agreement with Cabrillo Community College District to participate in the Bay Area Community College Consortium for the purpose of implementing the Strong Workforce Program; and
- a Los Medanos College renewal agreement with Contra Costa County, Office of the Sheriff to provide law enforcement courses.

Enrollment Campaign Contract

The Governing Board approved the contract to hire Interact Communications and Strata Information Group to lead the 4CD three-year enrollment campaign.

Project Stabilization Agreement

The Governing Board approved extending the revised Project Stabilization Agreement with the Contra Costa Building and Construction Trades Council for another five years.

The meeting was adjourned in memory of Marlan Shanks, DVC Professor Emeritus, and Blanca Perdomo, classified employee in the Foster Program at DVC and LMC.
