## Governing Board Regular Meeting of December 8, 2021

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, December 8, 2021, beginning at 4:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

### Ward Redistricting

The Governing Board held a public hearing on a staff-proposed balancing of ward boundaries following the population changes identified in the 2020 Census. After listening to public comments, the Governing Board decided to seek additional information and options. Staff will bring ideas and suggestions to the regular December 15, 2021, Governing Board meeting for consideration. The deadline to submit the approved rebalanced ward boundaries is February 28, 2022.

### New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College amendment with Cabrillo Community College District to increase the budget and revise the effective date of an agreement to participate in the Bay Area Community College Consortium for the purpose of implementing the Strong Workforce Program;
- a new Diablo Valley College (DVC) agreement with Key Code Media, Inc., to provide consulting to colleges and professional development for faculty in the information and communication technologies sector;
- a new 4CD agreement with Collaborative Educational Leadership, Inc., to provide project management, including planning, organizing, coordinating and directing the three-year enrollment recovery campaign project; and
- a new Los Medanos College agreement with Jordyn Flores to serve as a mentor and supervisor for child development students' practicum hours.

### Out of State Field Trips

The Governing Board gave approval for three out-of-state field trips for students. Details of those trips are listed below.

- Approximately 30 students will travel to Spokane, Washington, for the Kennedy Center American College Theatre Festival from February 13, 2022, to February 19, 2022;
- approximately 30 students will travel to Honolulu, Hawaii, for the Aloha State Choral Festival from March 16, 2022, to March 20, 2022; and
- approximately 10 students will travel to Washington D.C., for the National Student Advocacy Conference from March 18, 2022, to March 22, 2022.

### **Organizational Meeting Date Approved**

Due to language in Education Code Section 72000, the Governing Board agreed to hold its annual organizational meeting on Wednesday, December 15, 2022.

### **Public Request to Investigate and Censure Governing Board President**

At the request of community member Maria Alegria, the Governing Board held a conversation to discuss the request to censure Governing Board President Andy Li for comments made at a previous public meeting. Following a public apology, the Governing Board agreed no further action was necessary.

The meeting was adjourned in memory of DVC student Chifrey Malto.
