## Governing Board Regular Meeting/Study Session of February 16, 2022

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting/study session on Wednesday, February 16, 2022, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

### Chancellor Resignation

The Governing Board reviewed and accepted the February 11, 2022, resignation letter of Chancellor Bryan Reece, who will be relocating back to Southern California and spending more time with family.

### Professional Development Presentation

The Governing Board heard a study session presentation about ongoing professional development activities that contribute and cultivate a culture of engagement throughout 4CD.

### New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Diablo Valley College (DVC) renewal agreement with Denise Moss to coordinate activities related to the Bay Region Summer Cyber Camps and fall/spring cyber competitions for local middle, high school and community college students;
- a new 4CD agreement with Gooseneck Solutions, LLC, to provide negotiating services for Public Employees Union, Local 1; and
- a new Los Medanos College agreement with Lawrence Berkeley National Laboratory to allow biology courses at the Brentwood Center to utilize EcoFab equipment for the purpose of student research projects.

### Interim Chancellor Contract Approved

The Governing Board approved a contract, effective February 16, 2022, for Mojdeh Mehdizadeh to serve as the Interim Chancellor for the period of February 16, 2022, through June 30, 2024, at a starting annual base salary of \$357,714.

### Non-Resident Tuition Fees

Given the impacts of the ongoing pandemic, the Governing Board approved the recommendation to maintain the same non-residential tuition fee of \$290 per semester unit and a \$10 capital outlay fee for the 2022-23 fiscal year, commencing with the 2022 summer session.

### **Black History Month Resolution**

Approval was given by the Governing Board to acknowledge February 2022 as Black History Month. Celebrating this year's theme of "Black health and Wellness," the resolution supports and values events and activities that recognize and honor the contributions of Black people within the local and national economy, culture and identity of our democracy.

The meeting was adjourned in memory of retired DVC professor Mark Levine, retired Human Resources Operations Manager Sandi McCray, retired Districtwide Director of Financial Aid Tim Bonnel, and former DVC computer science professor Tony Russo.
