Governing Board Regular Meeting/Study Session of September 8, 2021

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting/study session on Wednesday, September 8, 2021, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Equity Gap Study Session

The Governing Board held a study session on Strategic Direction 2: Decrease Equity Gaps for All Students. The presentation included college updates on Student Equity Plans and impactful strategies implemented.

2021-22 Adoption Budget

The Governing Board held a public hearing and approved the 2021-22 Adoption Budget.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College (CCC) renewal agreement with The Wright Institute to provide clinical mental health services to students, including intake, assessment, therapy, crisis counseling, referrals, and group therapy;
- a Diablo Valley College (DVC) renewal agreement with Chappell University to provide allplatforms and services to deliver the annual WASTC ICT Educators Conference;
- a new District agreement with EideBailly LLP, to provide a comprehensive audit including the three foundations, bond financial and performance audits, and other post-employment benefits trust; and
- a Los Medanos College renewal agreement with Virus Geeks to administer and process COVID-19 testing for student athletes.

Final 2020 Accreditation Follow-up Report

The Governing Board approved the Final 2020 Accreditation Follow-up Report. The report will be submitted to the Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges by the established October 1, 2021, deadline.

Vaccine Policy

The Governing Board approved the Vaccination Policy Resolution, which will be implemented November 1, 2021, for all employees and those students who attend at least one in-person class, or visit a 4CD facility.
