Governing Board Regular Meeting of March 8, 2023

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, March 8, 2023, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Purchasing Agreements Approved

The Governing Board approved a number of agreements, including:

- a new Contra Costa College agreement with Immigrant Legal Defense to provide immigration legal services to community college-affiliated individuals;
- a Diablo Valley College (DVC) renewal agreement with Food Bank of Contra Costa and Solano to provide non-perishable and perishable food to college pantries that serve students in need and their families;
- a new 4CD agreement with Strategic Energy Innovations to advance energy and sustainability education and workforce development through experiential learning; and
- a new Los Medanos College (LMC) agreement with Monterey County Fire Training Officers Association to provide fire marshal courses required for faculty to teach fire technology and/or academy courses.
