Governing Board Regular Meeting of May 10, 2023

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, May 10, 2023, at 4:30 p.m., followed by closed session, and continuation of public session at 6:00 p.m., the highlights of which follow.

Special Recognition by Congressman DeSaulnier

Field representative Aaron Sanchez from Congressman DeSaulnier's office provided Director of Communications and Community Relations Tim Leong with a Certificate of Special Congressional Recognition for his outstanding and invaluable service to the student leaders of the Associated Students of Diablo Valley College (ASDVC).

Student Housing Feasibility Planning

The Governing Board heard an update on 4CD's exploration into building affordable student housing, and the submission of a grant to seek funding from the State Chancellor's Office to construct student housing.

Hispanic Serving Institutions

A presentation was made to the Governing Board outlining the objectives, outcomes and lessons learned from Hispanic-Serving Institutions' grants administered by Contra Costa College (CCC) and Los Medanos College (LMC).

Outgoing Student Trustee

The Governing Board presented Surpreet Kaur with a Certificate of Appreciation and a sash to be worn at commencement for her service as Student Trustee from June 2022 to May 2023.

Purchasing Agreements Approved

The Governing Board approved a number of agreements, including:

- a CCC renewal agreement with Chabot-Las Positas Community College District to participate in the California Early Childhood Mentor Program;
- a Diablo Valley College (DVC) renewal agreement with Carpenters Training Committee for Northern California to establish mutual goals and responsibilities to train participants for entry into the Northern California Carpenters Pre-Apprenticeship Program;

- a new 4CD agreement with Claremont Behavioral Services, Inc., to provide services for the Employee Assistance Program; and
- a LMC renewal agreement with Contra Costa County, Office of the Sheriff to renew the master instructional services agreement to provide law enforcement courses.

Resolutions Approved

The Governing Board approved two resolutions celebrated in the month of May: Support of Asian Pacific Islander Desi American Heritage Month and Support of Mental Health Awareness Month.
