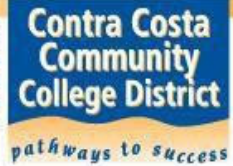

Governing Board Regular Meeting/Study Session of November 9, 2022

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting/study session on Wednesday, November 9, 2022, beginning at 5:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Community Partners Presentation

The Governing Board heard a presentation on 4CD's Strategic Direction 3: Educational Partnerships to Strengthen Student Pathways. Staff who contributed to this report were:

Purchasing Agreements Approved

The Governing Board approved a number of agreements, including:

- new CCC agreement with the California Community Colleges Chancellor's Office to receive the Rising Scholars Network grant to provide funding to establish degree-granting programs in correctional facilities and on-campus support for justice-impacted individuals;
- a DVC renewal agreement with Rainbow Community Center to provide four LGBTQIA+ and cultural humility training sessions for students and staff;
- a 4CD renewal agreement with Central Education Services to provide international student recruitment, marketing, consultation, advising, and application support; and
- a new LMC agreement with Teachstone, Inc., to facilitate the videography of teaching techniques.

Out-of-State Field Trips

As listed below, the Governing Board approved three out-of-state field trips for students at CCC and DVC.

- Five CCC students will travel to Orlando, Florida, to attend the National Jazz Education Conference from January 4, 2023, to January 8, 2023.
- Six CCC students will travel to Spokane, Washington, to attend and compete in the Kennedy Center American College Theatre Festival 2023, Region 7, from February 19, 2023, to February 25, 2023.
- Ten DVC students will travel to Washington, D.C., to attend the National Student Advocacy Conference from March 17, 2023, to March 23, 2023.
