Governing Board Regular Meeting Session of July 12, 2023

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, July 12, 2023. Closed session began at 5:00 p.m., and public session continued at 6:20 p.m. Highlights are listed below.

Distance Education

The Governing Board received a presentation on 4CD's Distance Education enrollments, student preferences and success. Also, they learned about the professional development opportunities that were provided, as well as innovative technologies and Open Educational Resources in relation to engaging students and reducing barriers to learning for those who are disproportionately impacted.

Purchasing Agreements Approved

The Governing Board approved a number of agreements, including:

- a Contra Costa College renewal agreement with the California Department of Education to provide early childhood education to preschool-aged children;
- a Diablo Valley College (DVC) renewal agreement with Rainbow Community Center of Contra Costa County to provide LGBTQ and cultural humility training sessions for students and staff;
- a 4CD renewal agreement with Simpson Investigative Services Group to provide consulting services and pre-employment background investigations for 4CD police services; and
- a Los Medanos College renewal agreement with the Foundation for California Community Colleges to reimburse 4CD for Linda Collins serving as Executive Director of the Career Ladders Project.

Out-of-State Field Trip

The Governing Board approved an out-of-state field trip for approximately 30 DVC students who will travel to Reno, Nevada, for a campus tour of the University of Reno from August 1, 2023, to August 2, 2023.

Citizens' Bond Oversight Committee Membership

Edward Wong was approved to serve as the DVC Student Representative for the 4CD Citizens' Bond Oversight Committee.

Permanent Chancellor Search

Pursuant to Human Resources Procedure 1010.06, the Governing Board announced its decision to approve the staff recommendation to begin the recruitment process for a permanent 4CD Chancellor.
