Governing Board Meeting of November 8, 2023

The Contra Costa Community College District (4CD) Governing Board conducted a regular meeting on Wednesday, November 8, 2023, beginning at 3:00 p.m., followed by closed session, and continuation of public session at 6:00 p.m.

Highlights are listed below.

Special Report on COLA

The Governing Board received a special presentation on how California funds cost-of-living increases (COLA), and its impact on 4CD's annual budget.

Purchasing Agreements Approved

The Governing Board approved a number of agreements, including:

- a continuing Contra Costa College (CCC) agreement with Kristina Moore to provide master scheduling, planning, education plan counseling, and enrollment assistance for students;
- a Diablo Valley College (DVC) continuing agreement with Campus Labs, Inc., to provide a web-based student organization management tool to increase communications and improve training of student leaders and advisors;
- a new 4CD agreement with Kamrin Communications, LLC, to provide editorial calendar, articles, and partnership with an in-house contractor team; and
- a new Los Medanos College agreement with California State University East Bay to support the East Bay Concurrent Enrollment program for students seeking to obtain their Bachelor's degree in Nursing.

Compensation for Management, Supervisors and Confidentials

Approval by the Governing Board was given to the agreement reached with Management Council Executive Board of an on-schedule increase of 6.15% for 2023-24, retroactive to July 1, 2023.

Amended CCAP Agreements

The Governing Board approved amended agreements between DVC and the Martinez Unified School District, and DVC and the Mt. Diablo Unified School District.

Resolutions Approved

The Governing Board approved the following resolutions, in honor of:

- Native American Heritage Month; and
- Veterans and All Persons Currently Serving in the Armed Forces of the United States of America, Our Employee Veterans and Our Student Veterans.

Annual Organizational Meeting

The Governing Board approved December 13, 2023, as the date to establish their organizational meeting, in which they will elect a president, vice president, and secretary.

The meeting was adjourned in the memory of retired CCC football coach Vince Maiorana.
