New Proposed Resource Allocation Model

Cabinet continued their review and discussion on a suggested draft allocation model for the District. Input was provided on the proposed allocation model, management funding model, and associated policies and procedures.

FTES Goals Discussed

Cabinet discussed FTES projections for 09-10 given the unstable state funding landscape. Further review will be conducted and revised targets may be appropriate.

Police Services Department Review

Cabinet reviewed the overall Police Services Department program and budget for the past five years.

Capital Outlays

Cabinet reviewed LMC capital projects that were previously approved for state matching funds. Given the unstable state funding landscape, those funds are potentially in jeopardy. Different alternatives were discussed and Cabinet agreed to move forward and fund the capital projects.
