The Governing Board unanimously approved the resolutions listed below.

- In Support of Community College Month, April 2022;
- Endorsing the Citizens' Bond Oversight Committee under the District's Property and Liability Insurance Coverage; and
- Continuing Governing Board Authority to Hold Virtual Meetings Pursuant to Assembly Bill 361.

New Agreements Approved

The Governing Board approved a number of agreements, including:

- a CCC renewal agreement with Catholic Charities of the East Bay for selected student workers to participate in an off-campus work study program;
- a new DVC agreement with Paradigm Shift for speaking engagements to the Upward Bound Program;
- a 4CD renewal agreement with Regroup to provide emergency notification platform services for students and staff through various methods; and

- a new LMC agreement with Hanover Research Council to provide continuous access to professional and certified researchers, an online library of previously commissioned studies, and proprietary dashboards compiled by institutional data.
