## **DVC's Deborah Dahl-Shanks Selected for Statewide Part-time Faculty Advocate Award**

**Deborah Dahl-Shanks**, a part-time Diablo Valley College music instructor has always considered former DVC professor Margaret Quan a mentor for her tireless efforts advocating on behalf of part-time faculty.

In March, Dahl-Shanks learned that she was truly following in her mentor's footsteps when she was awarded the Part-Time Advocate of the Year award from the Faculty Association of California Community Colleges (FACCC), an honor named for Quan, who served on the FACCC board and was the first honoree to receive the award six years ago.

"This award is presented to an outstanding part-time faculty advocate whose work impacts faculty statewide," says **Jeffrey Michels**, president of the United Faculty for the District. "Deborah does an amazing amount of work both locally for our teacher's union and on a statewide level."

Dahl-Shanks, who has been at DVC since 1986, says her greatest contribution has been in the area of retirement planning. She currently volunteers her time leading retirement workshops across the state and working with union leaders and part-time

faculty members to help them fully understand their retirement options. She also promotes legislation for part-time faculty which had included advancements in unemployment rights and retirement opportunities, qualifications and benefits.

"Some of our part-time faculty have full-time jobs in the private sector, others are only teaching a class or two or trying to piece together a full-time teaching job at a variety of colleges, while others are retired from their jobs and are looking to stay active," she says. "I feel it's important for all of our part-time faculty to know how to make the right choices when it comes to retirement. Teaching the workshops is truly a labor of love."

#### **Chancellor Helps Obtain Feedback on Financial Aid Challenges**



Twenty participants, including many from our college financial aid departments, attended a briefing session by the Advisory Committee on Student Financial Assistance (ACSFA) on Friday, March 27, 2009. Hosted by Chancellor Helen Benjamin and held at the District Office, the briefing helped ACSFA staff obtain input on several major financial aid topics --Simplification of Student Aid and **Higher Education Regulations** Study -- requested by Congress and the Secretary of Education.

#### **Campus Alert System is Coming**



The District is progressing on schedule with the installation of the new Campus Alert System (CAS) which will alert and disseminate information in case of an emergency or crisis situation. The alert system is being installed at Contra Costa College, Diablo Valley College, Los Medanos College, San Ramon Campus, and is integrated with the Contra Costa County Community Warning System (CCC CWS).

The CAS is scheduled to be ready for service in early May 2009, and will be tested on a monthly basis similar to the schedule already in place by other entities that are part of the CCC CWS.

The monthly test will occur on the first Wednesday at 11:00 a.m., lasting approximately 30 seconds, and will have the traditional siren sound. In the event of a real emergency or crisis situation, the siren sound would last three minutes.

"We have been working closely with the CCC CWS since we began planning for this installation," says District Emergency Services Coordinator **Teddy Terstegge**. "In our county, there are a number of potential situations that may call for alerting our community to take action, and the District's CAS is another important step towards ensuring our community's safety."

Outreach campaigns are being implemented to educate students, staff and the neighboring campus communities on what to do when the CAS is activated. When you hear the siren alert, you should follow the procedure of **Shelter** (go indoors), **Shut** (close and lock all doors and windows, turn off ventilation systems), and **Listen** (obtain more information from KCBS AM 740 or FM 106.9, or KTVU-2. The latest emergency information will also be on the District website. Posters will be displayed throughout the campuses, stories run in the college papers, and permanent signage installed on campus with visual reminders on what steps to take when the system is activated.
