

## **District Welcomes New Administrative Services Vice Chancellor**



After completing a nationwide search, the District selected **John al-Amin**, Ph.D., as the new Vice Chancellor of Administrative Services. He will oversee Finance Services, Facilities including Measure A bond-funded projects, and Police Services.

John brings over 14 years of experience performing managerial/supervisorial level duties in the areas of financial services, facilities operations, and economic research. His community college experience includes serving as the vice president of business services at Oxnard College, vice president of administrative services at Grossmont College, and Business & Administrative Services manager at Laney College. John also worked at the

California Department of Finance as a finance budget analyst for four years.

"The opportunity to work at a District level in a multi-college district was the logical next step in my career," says al-Amin. "I grew up in Oakland, and this position gave me the right reason to come back home and work in the Bay Area. Everyone has been so welcoming, and I want to thank everyone for making the transition so easy."

John has a Bachelor of Arts in Economics and a Master of Arts in Education from the University of California, at Riverside. He also earned his Doctor of Philosophy, Management, from California Pacific University.

John started his new position on February 1, 2012, and is located on the 5<sup>th</sup> floor of the District Office.





#### **New Services Offered at CCC**

More than 12 million students nationwide attend community colleges each year, yet many are unable to complete their studies. While there are many obstacles to retention and success, financial concerns are usually mentioned as one of the greatest impediments to student success. A new program at Contra Costa College (CCC) is helping students overcome these barriers.

CCC is partnering with Single Stop USA, a non-profit organization that works with community colleges across the country to provide students with access to screening for government benefits like health insurance and food stamps, as well as legal services, financial coaching and tax preparation. All services are completely free and geared toward helping students take advantage of more than \$65 billion in government resources and tax credits that go unclaimed every year.

In 2009, Single Stop USA and their partners helped over 120,000 families across the nation access resources worth more than \$300 million.

The Single Stop concept is being piloted at CCC with the goal of expanding the program to the other colleges in the future. Services are available for any current students and immediate family members including those at Diablo Valley College and Los Medanos College.



CCC Single Stop Site Manager **Teresea Archaga** has already begun helping students access federal programs.
Any current student and immediate family members are eligible to take advantage of this new free service.

**Teresea Archaga**, former LMC career development services coordinator, is the interim Single Stop site manager located in the CCC Student Services Center, Room 106. She previously worked at Rubicon Programs in Berkeley, and is thrilled to be helping students obtain free services that can help them succeed in college.

"I feel this position was custom made for me," says Archaga. "I worked with a similar clientele at Rubicon Programs, and now I have the opportunity to help our students become self-sufficient and successful."

Free tax preparation services are currently being offered 5-days a week. Financial coaching is set to begin in the near future and legal services are projected to begin in fall 2012.

"Thanks to everyone here at CCC who has been so welcoming and supportive," says Archaga. "Keep those referrals coming!"
