Governing Board Reviews Revenue Options

The Governing Board listened to a presentation at their April 25, 2012, meeting from Alex Evans of EMC Research, Incorporated, on findings of their recent telephone survey on potential 2012 revenue measures for the District. Approximately 1,200 likely voters were surveyed on their opinions should the District decide to pursue a facilities bond measure or parcel tax in the November 6, 2012, election. In addition, the survey also measured the level of support for the creation of school facilities improvement districts (SFID) for LMC and DVC. The Governing Board already approved the establishment of an SFID for CCC at a previous meeting.

While the survey results supported both revenue options could be successful, Mr. Evans indicated the District could be well served by seeking a Districtwide parcel tax instead of another bond measure. In particular, he noted that there is still a sufficient amount of unspent money from the 2006 Measure A bond, and voters may not support the urgency of another facilities bond.

A parcel tax is a common revenue generation measure used by K-12 districts and so far only a few California community colleges have pursued this funding option. One reason for not pursuing a parcel tax is the passage rate – you must receive support from 66.6 percent of the property owners while a bond measure only requires a 55 percent passage rate. In addition, funds from a bond measure can only be used for capital projects outlined in the bond measure, while funds from a parcel tax are less restrictive and can be used for operational purposes.

"The Governing Board has directed staff to begin the process for placing a parcel tax on the November 2012 ballot," says Chancellor **Helen Benjamin**. "We believe Contra Costa County property owners understand the challenging fiscal climate we have been facing over the past few years, and they are ready to help us."

Approximately \$4 million could be generated every year through the passage of a parcel tax should the District seek the suggested amount of \$11 per parcel. The new money will help lessen the reduction of student programs and services resulting from state budget reductions.

Upon approval by the Governing Board, a campaign will be created to ensure the passage of the parcel tax. More details will be shared later including opportunities to volunteer for the campaign. Participation in the campaign cannot be performed during the time in which employees are being paid to work their normal job duties and hours.

Denise is a resident of Mather, California, and is currently the vice president of student development and enrollment management at Folsom Lake College. She has served in her current position as a senior manager since 2005 and made contributions to the success of students at the college and district levels. Prior to assuming the vice presidency, she worked at Chabot College as dean of counseling and matriculation and EOP&S/CARE coordinator at Las Positas College. She comes to the District with a stellar background and is known for her honesty, integrity and passion for meeting the needs of students.

She earned an undergraduate degree in psychology and a master's in counseling/student development in higher education at CSU Long Beach, and obtained her Ph.D. in College Student Personnel Administration at the University of Maryland at College Park. Dr. Noldon has taught at Drexel University and Oregon State University, and served as a counselor during her career.

Bob is a resident of Livermore and is currently the Vice President of Administrative Services at Las Positas College. He has worked in the Chabot-Las Positas Community College District since 2002, and served as the interim President at Las Positas College during the 2007-08 academic year. Bob was considered very effective as the interim president by the Las Positas College faculty, classified staff and management employees. He comes to us with considerable experience, strong background in finance, a reputation for honesty and integrity, support for student success, and strong interpersonal skills.

His higher education experience includes leadership roles at both California State University, Dominguez Hills and California Polytechnic State University, Pomona. He earned an undergraduate degree in English and a master's in Public Administration at the University of Southern California, and is currently enrolled in the Ed.D. program at CSU, Stanislaus.

Transitional activities are planned for both during May and June at the college and District levels. Their full employment will begin on July 1, 2012.

Districtwide Achievement Gap Conversation

Oⁿ Friday, April 27, 2012, the District held their 5th districtwide conversation on the achievement gap in the DVC cafeteria. Chancellor **Helen Benjamin** kicked off the meeting with some opening remarks, and then introduced Assemblymember Joan Buchanan who applauded the work of community colleges despite the tremendous challenge we face as a result of state budgetary reductions.

Following brief updates from each of the presidents on work being done at the colleges, attendees heard from three programs – Career Advancement Academy, Umoja, and Puente – that are delivering promising results with underserved populations. In addition, students from these programs gave their thoughts on what is working with the programmatic interventions around equity being implemented.

"I thought it was extremely important and refreshing to give students the opportunity to speak for themselves on our District achievement gap conversation," says DVC's EOPS student services and instructional support coordinator **Lindsay Kong**. "To discuss the ways we can address the achievement gap, as we have done for the last year, without also hearing from students does a disservice to our good intentions and actions."

The final segment of the meeting focused on identifying what professional development activities could be implemented districtwide to continue our success.

"These conversations are very inspiring," says vice chancellor of education and technology **Mojdeh Mehdizadeh**. "The students told us there are things we can do to help all students achieve to their full potential that really don't cost a lot of money, and I can't wait to implement some of the professional development ideas that attendees shared so we can increase our student success effort."

LMC Receives Campaign for College Opportunity Recognition

os Medanos College (LMC) was one of five California community colleges recently recognized by the Campaign for College Opportunity for instituting practices or programs that move more students through college and onto a four-year university or the workforce. Through the use of the "Equity Scorecard" created by the University of Southern California's Center for Urban



Education (CUE), LMC is making progress to close the gap in success for underrepresented students.

In partnership with CUE, LMC began in 2008 to examine institutional practices ranging from instruction to student services. By utilizing the action research tools of the Equity Scorecard to examine its practices, LMC initiated changes to bring about more equitable outcomes among racial-ethnic groups of students enrolled at the college.

"LMC's Hispanic-Serving Institutions Grant has allowed us to continue our work with CUE and the application of the Equity Scorecard," says project manager of the Hispanic-serving Institutions Grant **Rosa Armendariz**. "I am proud to see the work of our Inquiry Team has led to sustainable shifts, including: leadership development on equity issues for our staff, a focus on how to improve success and transfer eligibility for all of our students, and identification of scalable practices for the institution. Now, we must continue the course to see real changes and benefits for students."

Founded in 2003, the Campaign for College Opportunity's mission has been to ensure that all eligible and motivated students in California have an opportunity to go to college and succeed. The Campaign remains committed to keeping the State of California from breaking its promise of college opportunity to its next generation of young people in order to ensure a strong state for all of us.
