New Governing Board Members Sworn In

The December 12, 2012, Governing Board meeting was full of energy and excitement as the District conducted ceremonies to recognize the two newly-elected members. Friends, family and elected officials attended this meeting to celebrate the occasion and congratulate the new board members on their election to a four-year term. Vicki Gordon replaced Tomi Van de Brooke, and Greg Enholm replaced Robert Calone, representing Wards 2 and 5, respectively.

Vicki Gordon was born and raised in the East Bay and is a Diablo Valley College alumna. She graduated from California State University East Bay (CSUEB) with a B.S. in Business Administration, and later returned to CSUEB for her teaching credential and has taught in both the Pittsburg Unified School District and Martinez Unified School District (MUSD). She was elected to the MUSD Governing Board in 1997 and served for over 15 years.

Ms. Gordon has worked as a community volunteer raising money for libraries, music, sports and classroom technology. She has also partnered with Martinez community leaders to help keep classroom sizes small, and bring green technology and innovative programs to school sites. Ms. Gordon is looking forward to the new challenge of working in higher education, forging closer ties between K-12 districts and community colleges, and making efficient use of the taxpayers' money.

Vicki's family has a long tradition of supporting education in the county. Her father-in-law, the late George R. Gordon, was one of the founders of the Contra Costa Community College

District. Vicki's mother, Brenda Byers, was a MUSD teacher and administer for 30 years. Vicki and her husband, Scott, have two children; Laura and Steven.

Greg Enholm has been a homeowner in East Contra Costa County since 1996. His community involvement includes representing non-Concord residents on the Concord Naval Weapons Station reuse planning committee, and serving on the Ambrose Recreation and Park District Board. He continues his appointment as District 5 County Library Commissioner, and as a member of the Contra Costa County Democratic Central Committee.

Mr. Enholm has worked as a financial economist for the Wisconsin utility regulatory commission, a securities analyst at Merrill Lynch Mortgage Capital, Inc., and was a vice president at Salomon Brothers in the stock research department where he advised institutional investors worldwide on electric utility stocks.

Mr. Enholm established his own financial advisory firm and published two books on utility financial and regulatory issues. Greg has been a high school math teacher in both public and private schools, and received a California Clear Single Subject (Mathematics) Credential from CSUEB. He also taught math at Heald College and is now a professor at DeVry University.

Greg earned a bachelor's degree in business administration and a master's degree in economics from the University of Florida in 1974 and 1975.
