classified professional in the past five years to receive this distinguished statewide award.

"It is an honor to recognize and celebrate these outstanding partners whose work is shaping the educational experience for our students and helping to build a climate that fosters success," said California Community Colleges Board of Governors President *Cecilia V. Estolano*. "They work extraordinarily hard each day to support our students, and on behalf of the system we thank them for their outstanding contributions."

Established in 2008, and first handed out in 2009, the award is presented annually to community college classified employees who demonstrate the highest level of commitment to professionalism and the community colleges. Recipients are nominated by members of their college or district community and endorsed by their local board of trustees. Representatives of the California Community Colleges Board of Governors, the California Community Colleges Chancellor's Office and the Foundation for California Community Colleges select the award recipients. The winners must have a record of outstanding performance on the job, as well as a record of active participation on campus and in their respective communities.

The Classified Employee of the Year Award is supported through a grant from the Foundation for California Community Colleges. Each recipient will receive a \$500 cash award and a commemorative plaque.

Kennedy King Scholarship Awards

The annual Kennedy King Scholarship Awards dinner commenced on May 19, 2017, at the Crowne Plaza Hotel in Concord, where 28 undergraduates and four graduates were recognized for their academic achievements. With family and friends surrounding them, proud recipients shared their educational aspirations now made possible through their scholarship awards.

Founded in memory of Dr. Martin Luther King, Jr. and Senator Robert F. Kennedy, the Kennedy-King Memorial Scholarship has granted nearly \$3,000,000 in scholarships to almost 600 students since its founding. All scholars have completed at least two years of study at Contra Costa College, Diablo Valley College, or Los Medanos College, and have been accepted at a four-year university to complete their undergraduate studies.

Contra Costa College Hosts Council for a Strong America Event

Public safety officers, students and community members gathered at Contra Costa College (CCC) to learn more about a new report released by Council for a Strong America spotlighting safety concerns. As California Director of the Council for a Strong America, former Assemblymember Susan Bonilla opened the event by praising CCC for its contribution to training California police officers and emergency medical services staff to help address a pending "skills gap" faced by employers statewide. Bonilla provided an overview of the new report, titled Public Safety, Public

Savings, which spotlights the role of community colleges in preparing students for jobs requiring some college credits, an associate degree, or a postsecondary vocational certificate.

Former CCC student and Richmond Police Officer Carmen Santana spoke to the crowd about her community college experience and path to law enforcement, noting her time at CCC as a pivotal point in her life. Richmond Police Chief Allwyn Brown, who serves on the Advisory Board of the Department of Public Safety at Contra Costa College, was also on hand to share his comments regarding the need for recruits with a variety of skills and knowledge. "We only want the best and brightest at Richmond Police Department, and we compete against the private sector for top talent just like any other employer," said Brown. "The importance of home- grown talent cannot be overstated. Our involvement with Contra Costa College gives us a seat at the table and allows us to shape curriculum and tailor training to our particular needs in law enforcement."

The event closed with live demonstrations performed by CCC students currently enrolled in the Emergency Services and Criminal Justice programs.
