## **Governing Board Selects Interim Chancellor**



Prior to becoming interim chancellor, Huff oversaw fiscal services, human resources, information technology, police services and risk management areas.

A t their regularly scheduled meeting on January 22, 2020, the Governing Board (Board) selected **Eugene Huff** as interim chancellor effective January 23, 2020, with an end date of December 31, 2020, or until a permanent chancellor is selected.

Huff began his service with the District in 2001 in human resources. He was promoted to Vice Chancellor of Human Resources in 2004 and Executive Vice Chancellor, Administrative Services in 2013.

Before coming to the District, Huff spent over a decade in the private sector in human resources and operations management roles, and led the start-up of the human resources function for a non-profit organization. He earned his bachelor's degree in Psychology and his master's degree in Human Resources Management from Purdue University.

"The Governing Board is excited and grateful that Gene has agreed to serve as our Interim Chancellor," said Board President Rebecca Barrett. "His many years of steady administrative leadership in the District has prepared him for this opportunity, and we are confident the District

will be in good hands until a permanent chancellor is on board."

The District will continue its national search for a permanent chancellor with the goal of announcing a new chancellor in April 2020, with a start date of June 1-July 1, 2020. Huff will not be a candidate for permanent chancellor.







New Senior Dean of Research and Planning, **Emma Blackthorne** attributes her interest in lifelong learning to her personal experience attending community college.

**D**r. Emma Blackthorne has been selected as the District's new Senior Dean of Research and Planning. Blackthorne's career has spanned various fields including anthropology, social work, instruction and criminal justice. She began working in higher education administration in 2007 at the Lac Courte Oreilles Ojibwa Community College located on the Lac Courte Oreilles reservation.

For Blackthorne, the experience felt like she was returning home, having spent her early years on her home reservation in Odanah, Wisconsin, as a citizen of the Bad River Band of the Lake Superior Tribe of Chippewa Indians. Her passion for education grew as she worked to bring GED and basic literacy to Natives in Northern Wisconsin Correctional Facilities, resulting in her selection as the Literacy Advocate of the year by Wisconsin Literacy, Inc. in 2009.

Blackthorne earned her bachelor's degree and

postgraduate certificate in Anthropology and Native American Studies from the University of Wisconsin, her master's degree in Social Work from Rutgers University in New Jersey and a doctorate from Capella University in Minnesota. Prior to joining the District, she acted as Interim Dean of Institutional Effectiveness, Research and Planning at Yuba Community College District in Yuba City, California.

Blackthorne is excited about the work she will do for the District and bringing her unique combination of experience to her new role. "The goal of the department is to help people inform their decisions about their institution; how to serve students to the best of their ability and how to make student success really amazing," shared Blackthorne.

## Jack Kent Cooke Foundation Scholarship Semifinalists

As a highly-selective scholarship program, the Jack Kent Cooke Foundation (JKCF) Undergraduate Transfer Scholarship attracts the nation's top community college students seeking to complete their bachelor's degrees. For several Diablo Valley College and Los Medanos College (LMC) students chosen as semifinalists, they are one step closer to winning the prestigious award.



At LMC, scholarship coordinator **Tammy Oranje** sees the students being selected as semifinalists who demonstrate perseverance in their pursuit of higher education. "They demonstrate a commitment to their education as well as a passion for their community," said Oranje. "Many times their educational goal is connected to the role they take in and outside of the campus community."

This year's 456 semifinalists were selected from an applicant pool of nearly 1,500 applicants attending 311 community colleges in 45 states and the District of Columbia. In order to be eligible, JKCF scholars must be currently enrolled in a community college and reside in the United States. JKCF transfer scholars are selected based on their exceptional academic ability and achievement, financial need, persistence, service to others, and leadership. Scholarship winners will be announced in April and receive generous financial support for up to three years, comprehensive educational advising and the opportunity to network with fellow scholars.
