# Congressman DeSaulnier meets with Chancellors Cabinet

On August 31st, Congressman DeSaulnier attended Chancellors Cabinet, where Phyllis Carter, 4CD's new CFO, along with Kelly Schelin, AVC of Educational Services presented an overview of the federal pandemic relief funds (HEERF). 4CD was awarded \$97.3M; of that, over \$12.7M has been awarded to students seeking emergency grants.Cabinet members also shared ideas with Congressman DeSaulnier should there be additional federal pandemic relief funding.
